NATIONAL DELEGATE NOMINATION FORM



ELECTION OF 2018 - 2019 NATIONAL DELEGATES

This year, the NSCA membership will elect National Delegates who will assist in the governance of our association for the next two years. Everyone who is to be considered for election must appear on the ballot as a nominated candidate or as a write-in candidate. Current Delegates WILL NOT automatically appear on the ballot as candidates. U.S. states and other countries are allotted from one to five Delegates based on the number of members there. **Check MyNSCA.com for the number of Delegates allotted for your state/country.** We want every state to have the full voting power to which it is entitled, so please ensure that your state has adequate nominees to fill every position and urge every member to vote.

Please pay special attention to the requirements for an eligible nomination and election. The nominee and five endorsers must be current paid NSCA members, and all must live in the state that the nominee will represent. CLM and Crossfire members are not eligible to run for office, endorse a nominee, or vote. National Delegates are required to shoot a minimum of 500 registered targets each year, including the year immediately preceding their election year. Nomination forms must include all required information and must include the signature of five current members, with membership number included, and the candidate's signature and NSCA number on the same form. The nomination form must be received between July 1 - 22. Nominations may be emailed to gmoseley@nssa-nsca.com or faxed to 210-688-3014.

Ballots for each state/country will be emailed on August 1, 2017, to all current members with an email address on file. To be elected, candidates must receive at least five votes from current members living in their state. Ballots must be submitted no later than midnight, August 20, 2017. Votes will be tabulated within one week and elected delegates will be notified. If necessary, run-off elections will immediately follow. Results will be printed in the next available issue of Clay Target Nation magazine and posted on MyNSCA.com.

If you are nominating another person as a National Delegate, that person must sign the nomination form as the candidate willing to accept the responsibilities of the position. See Rule I-D-1 on page 9 of the 2017 NSCA Rule Book for the ratio of delegates to members per state.
