ELECTION OF 2019 – 2020 NATIONAL DELEGATES

This year, the membership-at-large will once again elect the National Delegates who will assist in the governance of our association. Current Delegates WILL NOT AUTOMATICALLY appear on the ballot as a candidate. Everyone who is to be considered for election must appear on the ballot as a nominated candidate or as a write-in candidate. We want every state to have the full voting power to which it is entitled; check the table to the right for how many delegates your state is eligible to elect. Each member in every state should share the responsibility of nominating enough potential National Delegates to fill all of the allotted slots as well as urge all other members in your state to cast a vote in the election.

First and foremost, the nominee and all five of the endorsers must be current members of the NSCA, and all must live in the state that the nominee will represent. **CLM and Crossfire members are not eligible.** All nomination forms must be received between June 6 – July 21, 2018. Emailed and faxed nominations will be accepted. Nomination forms must include all required information. Remember; a valid nomination form must include the signature of five current members with membership number included, along with the candidate's signature and NSCA number on the same form. Ballots will be emailed to all current members with an email address on file, by state, on August 1, 2018.

Please be aware that the NSCA will begin a new governance structure along with this election. In order to run for our newly formed Executive Council you must be an elected National Delegate. Additionally, to become an elected officer of the NSCA, you must have been elected to the Executive Council.

Nomination is only the first step in the procedure of becoming a National Delegate. To be considered valid, National Delegate ballots must be received at headquarters no later than 11:59 p.m. CST August 31, 2018. To be elected, candidates must receive at least five votes from current members living in their state. Votes will be tabulated as quickly as possible and elected delegates will be notified. Results will then be posted on MyNSCA.com as well as in Target Talk. Ballots for runoff elections, when necessary due to tied votes, will be sent out immediately after balloting is completed.

One last point to remember - if you are nominating another person as a National Delegate, that person must sign the nomination form as the candidate willing to accept the responsibilities of the position. **Please review the new NSCA Charter regarding National Delegate Elections for reference, found at MyNSCA.com in the "Members" section, Rule Book page.**
