IMPORTANT POINTS FOR CLASSIFICATION AND DOWN CLASS REFUSAL FORM

A shooter who has never shot any registered clay targets will be assigned **12ga Class C, Sub ga Class D**, Rule #V-A-1-b-1. According to page 15 of the 2025 online NSCA Rule Book, Rule #V-A-1-b-1-i: After the first 300 targets shot in 12ga. events with no punches, a classification review can be performed for the shooter's 12ga class by contacting headquarters via email at nbowers@nssa-nasca.com. The rules governing "Moving up in Class," "Reclassification," "Known Ability," and "Classification Reviews" will apply.

It is the shooter's responsibility to determine the number of punches won at any shoot and move up one class after reaching the required number. Always start your new class with 0 punches.

Please remember that punches are earned in all registered events that use the NSCA Classification system including 20ga., 28ga., and .410 bore as well as FITASC, NSCA 5-Stand, Super Sporting, American Field Sporting, Pump Gun and Side by Side events with 50 targets or more. League and Monthly Targets are excluded from receiving punches.

In January 2023 the NSCA Executive Council approved to carry over SUB-GAUGE ONLY punches for two years. This means that current punch count in sub-gauge classification includes all sub-gauge punches from shoot years 2023, 2024, and 2025.

A shooter who is assigned to a lower 12ga class may reject the class if the shooter wishes to remain in a higher class. To reject the assigned class, the shooter must sign the **Refusal Form** at the bottom of this page and return it to NSCA Headquarters immediately. A shooter who wishes to refuse any further end-of-year reviews may do so below or send your request in writing to: nbowers@nssa-nasca.com.

A shooter may also declare into a 12ga or sub-gauge class higher than assigned; however, the shooter must stay in that class or higher for the entire year. This applies to all classes **except Master Class** which must be earned and not declared. The only exception is a shooter whose current 12ga class is Master, they may declare master class for sub-gauge. All requests must be made via email to nbowers@nssa-nasca.com.

Upon entering a shoot with multiple events, a person will remain in the class he/she started in for **all** events held and any punches he/she accrues will be awarded at the conclusion of **all** events at that shoot.
